**Subject:- Request for intervention in the matter of granting of  
NFSG scale – Reg.**

Kindly refer to letters under even No. (55) dated 02.03.2009 & 103 dated 09.03.2009 on the above matter.

The Association in the above letters requested to issue clarification so that the Grade Pay of Rs. 5400/- is given to all Superintendents of Central Excise who have completed four years as Superintendent on 01.01.2006 or thereafter in view of the instances cited in the letters including the instance in CBDT in the same ministry. It was learnt that the clarification would be issued after General Election but till date no such clarification has been issued causing immediate problems to those officers who are retiring.

Further it is also brought to your kind notice that in some Commissionerates the Superintendents who got second financial up gradation in the Gr. A scale of Rs.8000-13500/ prior to 01.01.2006 under ACP Scheme, for failure to give them second promotion in the post of Assistant Commissioner within 24 years of service, have been placed in scale of Rs.8000-13500/ for Gr. B in PB-2 on 01.01.2006. The said placement degraded the Superintendents to Gr.B scale which is illegal and highly irregular and in this connection the Association draws your kind attention to para 6 of Annexur-I attached to the Modified Assured Progression Scheme(MACPS) under O.M. No.35034/3/2008-Esstt. (D) dated 19.05.2009, which says that in the case of all the employees granted financial up gradation under ACPS till 01.01.2006, their revised pay will be fixed with reference to the pay scale granted to them under the ACPS. Therefore, there is no doubt that the pay of the Superintendents who were given the Gr. A scale prior to 01.01.2006, shall be fixed in Gr. A scale of PB-3.

The Association requests to issue urgent clarification/ instruction for uniform practice throughout India.
