OFFICE ORDER NO.249/2010

The President is pleased to appoint the officers mentioned in **Annexure-I and Annexure-II** to the grade of Assistant Commissioner of Customs & Central Excise in Pay Band-3 with Grade Pay Rs. 5400/- (Rs.8,000-13,500 pre-revised) on promotion on purely *ad-hoc* basis, with immediate effect. The appointment is for a period of six months or until further orders, whichever is earlier.

2. The promotion, being purely on *ad-hoc* basis for a limited period of six months only, does not confer any right on the officers so promoted for any claim for continued officiation or regular promotion in the grade and the period of such service shall not count for seniority or as qualifying service for further promotions.

3. The *ad-hoc* promotions of the officers mentioned in Annexures-I and II shall be on *in-situ* basis, until further formal posting/transfer orders that will be issued separately.

4. The Commissioners concerned shall ensure that if any of the officers, whose name figures in the promotion lists at Annexures-I and II, is under suspension or facing any charge sheet or prosecution, he/ she shall not be allowed to assume charge in the grade of Assistant Commissioner and this fact be reported to the Board immediately.
