3. The promotion of the above mentioned officers to the grade of Deputy Commissioner of Customs & Central Excise is purely on ad-hoc basis and shall not confer any right on the officers so promoted for any claim for regular promotion in the grade and the period of such service shall not count for seniority or as qualifying service for further regular promotions.

4. The officers being promoted through this Order shall assume charge of the post of Deputy Commissioner in the same office in which they are currently posted.

5. The Controlling officers concerned shall ensure that the officers submitting Charge Assumption Reports pursuant to this promotion order are clear from vigilance angle.
